

Tulsa Ski Club – Trip Policies and Terms

PAYMENTS AND CANCELLATION: Trips require prepayment in full. One-third of the trip price must be paid to reserve a spot. However, payment in full must be received not later than 20 days prior to the "cancellation date" published on the Lift Line information for that trip, and sent by email to each trip participant. Cancellation may be made without forfeiture of costs if made 20 days or more prior to the "cancellation date." Refunds will not be issued until after the trip is complete. Cancellations made after the "cancellation date" will be subject to a penalty of all nonrefundable trip costs incurred by the Club for that member on that particular trip.

Note that trip prices are subject to change when caused by events beyond the control of the Tulsa Ski Club, such as fuel charges, currency exchange rates, etc.

The official trip wait list requires an amount equal to the non-refundable processing fee with registration.

NON-REFUNDABLE PROCESSING FEE: 4% of the trip cost already paid.

RETURNED CHECK CHARGE: \$25

MAXIMUM OCCUPANCY: Occupancy by extra persons in room, if available, requires agreement of all members in a lodging unit and all shall sign a "Maximum Occupancy" form.

DISCLAIMER OF TULSA SKI CLUB LIABILITY: Each member registering for a trip acknowledges and agrees, for themselves and any family member(s) accompanying them on any trip, that the Tulsa Ski Club is not responsible for, and disclaims any and all liability whatsoever in respect of any loss, expense, damage, injury, accident, delay, irregularity, or inconvenience, to the person or property of any trip participant, however occasioned, sustained, or suffered in or during any trip, journey, tour, or activity or in the carrying out of any arrangements booked by or through Tulsa Ski Club in connection with any trip.

DAMAGES: Any person causing damage to any form of transportation, accommodations, facilities, or equipment will be liable for said damages, and, by the act of registering for a Tulsa Ski Club trip, agrees that the registering member is responsible for and will pay for all such damages.

TRIP INSURANCE: Trip Insurance is always a wise move to protect you in case unexpected issues come up and you need to withdraw from a trip. There are many companies available with comparable coverage. You should choose the plan and company that is right for you. The purchase of Travel Insurance is not mandatory for our travelers to participate on any Tulsa Ski Club trip. The Tulsa Ski Club does not endorse, and is not affiliated with, any trip insurance companies. The Tulsa Ski Club bears no responsibility or liability for the sale, pricing or execution of this insurance in any way.
